LICENCE FOR IMPORT & EXPORT OF RADIATION GENERATING EQUIPMENT & RADIOACTIVE MATERIALS

1. Pursuant to Sections 18(2)(a)(b) and 21(1) of the Bangladesh Atomic Energy Regulatory Act No.19 of 2012 and subject to the conditions and limits incorporated herein, the Bangladesh Atomic Energy Regulatory Authority (BAERA) hereby issues the licence to-

for the import and export of radiation generating equipment and radioactive materials.

2. This licence is subject to the compliance of all applicable requirements as set-forth in the Nuclear Safety and Radiation Control Rules-1997(SRO No.205-Law /1997), in particular of those mentioned in Rules 10.1, 10.7, 10.13, 11, 14 and 54.

3. The licensee prior to import and export each consignment of radiation generating equipment and radioactive materials shall apply to the Authority for a permit for custom's clearance in prescribed form stated in Schedule-XVIII and on payment of the fees given in Schedule-VII as per provision of Rule 11.1 and shall submit alongwith the applications, technical details of the machines as required by Rule 11.2. The technical specification of the machines shall be in conformity with the requirements stated in items 3(i) of Schedule IX (Applicable Standard, Code and Guide) .

4. The licensee shall intimate the undersigned in writing the following information in a manner stated below :

- Numbers and particulars of each consignment of the radiation generating equipment and radioactive materials within 15 days of customs clearance ; and
- Names and detailed address of the purchaser of each radiation generating equipment and radioactive materials sold within 7 days of the sale.
